**NST AGM Decisions** 

1) Agenda: Change in the NST Bye Laws 7.b

The time for the second AGM to be called was changed from seven days to one month.

3) Agenda: Change in section 10.f. Hand-over timeframe changed from the first week of January to the first month of the year.

A hand-over from the outgoing EC to the newly elected EC shall occur by the end of January, according to the date recommended by the Election Committee.

4) Agenda: Formation of Honorary Past President's Council

#### **Honorary Past President's Council**

Members of the Honorary Past President's Council will serve as guides and coaches to the Executive Committee.

If NST EC is ceased, for any reason, NST Past presidents shall meet at their earliest and shall decide the course of actions.

5) Agenda: Drafting a Memorandum of Understanding with NCSC.

#### Memorandum of understanding with NCSC

#### **NST and NCSC:**

- 1. The NCSC was formed as a result of the efforts of NST.
- 2. Both are interrelated organizations of the same community with different objectives.
- 3. NCSC's Bylaws define that NCSC shall have two EC members from NST. NST shall reciprocate the same by having two EC members from NCSC NST EC shall have two EC members from NCSC.
- 4. NST shall have an agreement with NCSC to have its own separate office room in the NCSC's premises.
- 5. NST shall compensate a reasonable amount of variable costs of utilities, on a monthly basis for utilizing the premises, to NCSC. Such amount shall be determined, based on the actual variable cost, by both parties.
- 6. Considering the interdependencies of these two organizations of the same community, NCSC shall give priority to NST in booking the hall/premises or any other important events.
- 7. NCSC and NST would not interfere with each other's established programs or events. The two organizations would work together continuously to ensure the success of the programs.
  - 6) Agenda: Formation of Election Committee.

As per the Bye-laws 13.f: Election Committee shall be formed at least 3 months prior to the existing EC term ends
