NOMINATION FORM

Election of NST Executive Committee 2026-2027

Rules:

1. The candidate, nominator (person who nominates), and seconder (person who seconds) should be valid members of NST.
2. The candidate cannot be nominated or seconded by any other candidate.
3. One NST member can only be either one candidate, one nominator, or one seconder. Can't be a nominator or seconder for multiple candidates.
4. If the same person files for two positions, then both nominations will be disqualified, fee won't refund.
5. If the same member nominates or seconds for more than one candidate then only first will be valid.
6. The nomination form must be submitted in person. If someone is unable to make it in person to file or withdraw the nomination form, the Election Committee allows them to do so through a Power of Attorney.
7. The Power of Attorney is valid for nomination filing and withdrawal process only.
8. The Power of Attorney must be valid and notarized. Please download the Power of Attorney form and complete the process before submitting it to the Election Committee.
9. Candidates must submit proof of NST membership and a copy of their government-issued identification card.
10. The nomination form must be submitted with the appropriate fee. The fee must be cash, money order or cashier's check.
